4) Approve a resolution approving the Recognized Obligation Payment Schedule for July 1, 2013 to December 31, 2013 (ROPS 13-14A) and take related actions. Ms. Noel stated that the Department of Finance (DOF) has renamed the ROPS to "ROPS 13-14A" along with changing the form on which the ROPS is reported. She stated that it is similar to previous ROPS forms however the new form provides more detailed information. Ms. Noel emphasized that the purpose of the ROPS is to allow payments to be made therefore Staff generally overestimated payment amounts to ensure that sufficient funds are available, particularly related to the Pajaro Park and Merritt Street Projects.

Ms. Noel stated that construction of the Pajaro Park would commence soon. She also stated that the Castroville Community Services District recently completed the preparation of an environmental review document which caused a delay in the schedule for the Merritt Street Project. Ms. Noel reported that concerning the contingent liability claims for the School Districts that the Successor Agency's counsel has advised that they are working on a

settlement agreement. The amount shown on the ROPS may need to be amended once the agreement is finalized and approved. Ms. Calderon briefly reviewed the ROPS with the Committee. . Supervisor Calcagno motioned to approve a Resolution approving the ROPS. Seconded by Mr. Muñoz..

The Department of Finance (DOF) has accepted the Housing Due Diligence Review and staff is working with them on final questions on the Non-Housing Due Diligence Review. She stated staff will begin working on the Property Management Plan that is required by DOF which will be eventually brought before the Oversight Board for approval.
