MONTEREY COUNTY PLANNING COMMISSION SEPTEMBER 24, 2003 MINUTES

The Planning Commission met at 9:05 a.m. at the Board of Supervisors Chambers of the Courthouse at 240 Church Street, Salinas, California.

<u>COMMISSION</u> – Commissioner Gonzalves advised the Commission that he will be resigning and moving to the Los Angeles area.

Commissioner Diehl said she was sorry to hear that Commissioner Gonzalves would be leaving and thanked him for the time served. She informed the Commission that she had attended the opening for the Robert Louis Stevenson project. It was an interesting building because it incorporated a number of innovative elements that they actually list in the tour and showed 30 sustainable elements. It was a fascinating experience to see how they turned out. The architect spoke about some of the challenges he faced in the building process as he tried to implement some of these new procedures through building and related inspections. In many cases there were no ordinances that directly addressed the proposals that they were implementing and that meant the burden of proof on the safety and appropriateness of them was on the applicant and the applicants representative and that added a great deal of difficulty to the building and implementation. As we go forward with the General Plan, we should leave opportunities for this kind of innovation in the plan so if people do come forward with more efficient or more earth friendly practices that are safe and appropriate, that we do keep room for those in our building and inspection practices so that they don't become unattainable because of regulation.

Commissioner Errea spoke to differing regulations for private vs. public school buildings and that County Building regulations may be superceded by state regulations and questioned whether this would have an effect on Commissioner Diehl's comments. Commissioner Diehl responded that the Architect advised that he was complying and working with County Building Inspection and regulations

2. ASSOCIATION OF SPRECKELS RESIDENTS (FEE WAIVER) (PD030086)

Staff recommended denial of the fee waiver for the appeal on the Parcel Legality Status Determination on the legal status of 72 parcels in Spreckels. (See Item #3 below). Staff distributed a letter dated September 24, 2003 from Michael Cling, representative for the Tanimura family and owners of the 73 lots of record in Spreckels, in which he concurs with staff's recommendation.

Mike Meuter and Elizabeth Panetta spoke for the fee waiver.

Michael Cling spoke in opposition.

It was moved by Commissioner Errea and seconded by Commissioner Wilmot to deny the fee waiver.

3. ASSOCIATION OF SPRECKELS RESIDENTS (PLN030380)

Staff recommended that the Planning Commission uphold and affirm staff's administrative interpretation of the term "an interested person" as used in Section 19.14.045 of the Subdivision Ordinance, to mean a property owner or a property owner's vendee pursuant to a contract of sale. This recommendation would deny standing to the Association of Spreckels Residents to request a Parcel Legality Status Determination on the subject parcels.

Peter Davis, representative, had questions related to Condition #7, landscaping. After discussion it was agreed to change "screen" structures visible from Los Laureles Grade and Corral de Tierra Road and to ensure views of Castle Rock to "minimize" views of structures
