The Planning Commission met at 9:05 a.m. at the Board of Supervisors Chambers of the Courthouse at 240 Church Street, Salinas, California.

D. SCHEDULED ITEMS

1. <u>LAND USE ADVISORY COMMITTEE PROCEDURES AND BOUNDARIES;</u> <u>PROPOSAL TO INCLUDE RANCHO SAN CARLOS IN CARMEL VALLEY LUAC</u> BOUNDARY (PD030021)

Commissioner Hawkins went over the suggested new changes to the procedures.

Wendy Strimling, Deputy County Counsel, advised that the Commission on September 24th had passed a resolution of intent to approve procedures after they had been revised to include proposed changes.

After discussion, Commissioner Hawkins resigned from the subcommittee due to upcoming surgery and Commissioner Diehl volunteered as his replacement.

Public Comment: Marjorie Kay, Sharon Wood, Brian Finegan, Jan Mitchell, Barbara Rainer, Frank Crist, Greg Crist, and Joel Panzer focused among other issues the General Plan Update that the Board of Supervisors and Planning Commission heard the previous evening.

Commissioner Errea moved, seconded by Commissioner Brennan and passed by the following vote to continue this item to a future date to allow time for additional changes.

2. STORAGE PRO OF CARMEL LLC (PD030204)

Staff recommended that the Planning Commission adopt the resolution of intent to consider amendments to the zoning designation of the subject properties.

On October 8, 2003, during deliberation on adopting a resolution denying a self storage facility on the property (Mirabito, Case No. PLN980301), the Planning Commission directed staff to prepare a resolution of intent to consider changing the zoning of the subject properties as described above.

Upon adoption of the resolution of intent, staff will prepare an analysis of the zone change along with an environmental initial study, and present the analysis and recommendations at a public hearing before the Commission. After consideration of the analysis, environmental initial study and public comment, the Commission may then recommend that the Board of Supervisors approve or deny the zone change, based on findings and evidence.

Commissioner Brennan relayed that a group is being formed to address affordable housing issues in Carmel Valley.

Todd Bessire, representative, gave some history of the property.

Sharon Woods and Michael Hagerty spoke in favor of work force housing.

Commissioner Diehl moved, seconded by Commissioner Brennan and passed by the following vote to adopt Resolution #03067 to approve staff's recommendation.

3. MONTEREY COUNTY PUBLIC WORKS (PD030190)

Patricia Lopez presented the 2003-2004 Capital Improvement Program (CIP). Ron Lundquist answered questions.

State law requires that cities and counties follow their general plan when carrying out public works projects. In addition, right-of-way may not be acquired or disposed, streets may not be abandoned, and public buildings may not be built until the Planning Commission has reviewed the projects' conformance with the General Plan.

The Public Works Department annually prepares a composite list of those projects with a total cost exceeding \$50,000. Funding sources are described within the program. The CIP was submitted to the Planning Commission for review as to its conformance with the General Plan.

The five-year CIP is included in the Regional Transportation Plan (RTP), under State guidelines, recognizes land use development policies as the basis for the proposed transportation system.

4. DONANGELO MARK & JOANN (PLN030159)

Commissioner Diehl had questions regarding Condition #7, proof of water availability on the property.

8. BURLEIGH WILLIAM B TR (PLN030202)

Staff recommended that the Planning Commission deny the appeal and affirm the opinion rendered by the Department of Planning and Building Inspection.

Brian Finegan, representative, relayed his client's view that full restoration was not justified.

Commissioner Parsons moved, seconded by Commissioner Brennan and passed by the following vote to adopt Resolution #03072 to approve staff's recommendation to deny the appeal with an added finding that on April 8th the Director of Planning asked for restoration:

9. SHANKLIN WILLIAM & DOMINIQUE (PLN030074)

10. LAUBE SHELDON & NANCY (PLN010105)

Staff recommended adoption of Mitigated Negative Declaration with a Mitigation Monitoring and Reporting Program and approval subject to 25 conditions. The Big Sur Land Use Advisory Committee recommended approval. Staff advised that Environmental Health has added two additional conditions: 1) destroy and relocate existing septic tank, and 2) provide plans for the location of the dwelling, septic tank location and leach field.

Laura Lawrence, Environmental Health, reworded Condition #24, to destroy and relocate the existing septic tank.

Todd Bessire, representative, agreed to the conditions.

John Bridges, representative for Dr. and Mrs. Mc Callister, spoke in opposition.

Barbara Lane, a neighbor to the south of this parcel, spoke in favor.

Jeff Norman, project biologist, spoke regarding the Smith's Blue Butterfly habitat.

Tim Bratton, Mickey Muennig's office, spoke to siting of the house.

Mr. Laube rebutted.

Commissioner Diehl moved, seconded by Commissioner Brennan and passed by the following vote to adopt Resolution #03073 to adopt the Mitigated Negative Declaration with approval of the Mitigation Monitoring and Reporting Program and approve PLN010105 including deletion of Condition #24 and the addition of two Environmental Health conditions:
