COASTAL DEVELOPMENT PERMIT TO ALLOW A LOT LINE ADJUSTMENT BETWEEN TWO PARCELS THAT HAVE THE SAME ASSESSOR'S PARCEL NUMBER (008-293-021-000). THE PROPOSAL WILL MERGE THE TWO LOTS INTO A SINGLE LOT THEREBY ELIMINATING A NON-CONFORMING UNBUILDABLE LOT. THE PROPERTY IS LOCATED AT 3381 LAURELES LANE, PEBBLE BEACH (ASSESSOR'S PARCEL NUMBER 008-293-021-000), DEL MONTE FOREST AREA, COASTAL ZONE.
