# FINAL MONTEREY COUNTY PLANNING COMMISSION JUNE 8, 2005 MINUTES

#### 1. GENERAL PLAN UPDATE ON CIRCULATION RECOMMENDATIONS

Ron Lunquist, Public Works presented the General Plan Update on Circulation Recommendations and answered questions.

# 2. BRITTON DOUGLAS WAYNE (PLN040355)

Therese Schmidt, Project Planner, presented the Use Permit to allow the construction of a second story addition and expansion of the first floor by approximately 41 square feet to an existing single story residence within 200 feet of the Carmel River bank and Design Approval. The property is located at 64 Paso Hondo Road, Carmel Valley, Carmel Valley Master Plan Area.

Representative Marge Ingram-Thealis agreed to the conditions.

# 3. TANNAHILL DNALD WAYNE & TRENA (PLN040738)

Therese Schmidt, Project Planner, presented the Use Permit for outdoor externally illuminated back to back faced 10'6" x 36' advertising structure (billboard) supported by a single sign pole with an overall height of 35'. The sign will be located at 728 El Camino Real, Salinas, North County Non-Coastal Area. Staff relayed that Caltrans has made corrections to the overall height and illumination and 2 year limit of the Use Permit.

Public Comment: Gary Mobley, applicant, had objections to height and 2 year time limit. After further discussion, applicant withdrew his objections.

#### 4. PETER PAN INVESTORS (II) (PLN990376)

Eric Lee, Project Planner, presented the Combined Development Permit consisting of a Coastal Administrative Permit and Design Approval to allow the construction of a new 4,303 square foot three-story single family residence, 504 square foot detached garage, retaining walls, septic system, grading (approximately 610 cubic yards cut/295 cubic yards fill), and a drainage pipe and outlet located on an adjacent parcel; a Coastal Development Permit to allow the removal of four (4) protected trees (36" and 28" landmark Monterey pines and 13" & 6" oak trees); and a Coastal Development Permit for development on 30% slope. The property is located at 226 Peter Pan Road, Carmel, east of Highway One, Carmel Highlands Area, Coastal Zone.

Staff recommended adoption of the Mitigated Negative Declaration and approval of the Combined Development Permit.

The Carmel Highlands/Unincorporated Land Use Advisory Committee (LUAC) voted [6-0] to recommend denial of the project. They cited concerns related to the house design and neighborhood character, water credits, septic system, lighting, and retaining walls. The retaining wall application is being revised.

Carl Holm, Project Planner, presented the Land Use Plan Amendment and Zone change from outdoor recreation (OR) to Watershed and Scenic Conservation (WSC/40) for a 2.5-acre lot located north of Garrapata Creek, south of Garrapata Park and west of Highway One, Big Sur, Coastal Zone.
