Luis Osorio, Project Planner, presented the Minor Subdivision of a Combined Development Permit consisting of: 1) Lot Line Adjustment to adjust the boundary between two existing lots of record of 6.0 and 58.2 acres, resulting in two lots of approximately 14.0 and 50.2 acres respectively; and 2) Minor Subdivision tentative parcel map for the division of the resulting 50.2 acre lot into two lots of approximately 19.7 and 30.6 acres. The subject property is located at 29001 Robinson Canyon Road, (Assessor's Parcel Numbers 416-021-038-000 and 416-021-039-000), Robinson Canyon Road Area, Carmel Valley Master Plan Area.

Jody Lyons, Project Planner, presented the Minor Subdivision of a 121.23 acre parcel into three parcels, 40, 40 and 41.23 acres. The project area is located at the north end of Cross Road, Lockwood (Assessor's Parcel Number 422-081-047-000), South County Area.

3. RANCHO SAN ARDO LLC (PLN030471)

Paul Mugan, Project Planner, presented the Minor Subdivision to divide four parcels (Assessor's Parcel Numbers 422-101-061-000, 422-101-062-000, 422-101-063-000, 422-101-065-000 and 422-121-001-000) totaling approximately 567.76 acres into fourteen 40-acre parcels; a Use Permit for development on slopes in excess of 30 percent; and a Use Permit for a bed and breakfast on proposed lot 3; and a Use Permit for a wireless telecommunications facility. The project includes approximately 170,750 cubic yards of grading (86,750 cubic yards cut and 84,000 cubic yards fill) for road infrastructure and building pads. The property is located east of Lockwood San Ardo Road, southwest of Dudley Road, South County Area.

Staff requested a continuance to January 12, 2006 to allow time for further review.
