Subject: Suchy – PLN100126

Design Approval to allow the construction of a two-story 2,740.30 square foot single family residence and a 497 square foot attached two-car garage. Materials and colors consist of exterior stucco walls (Broken Arrow stucco), exterior accent color and trim (Middlebury Brown), metal clad wood doors and windows (Rustic Finish), and roof (Synthetic Slate with copper gutters). Grading is approximately 100 cubic yards of cut and 50 cubic yards of fill.

The property is located at 1046 Rodeo Road, Pebble Beach (Assessor's Parcel Number 007-323-012-000), Greater Monterey Peninsula Area Plan. The parcel is zoned Medium Density Residential with a Building site, Design Control and Recreational Equipment Storage overlays (MDR/B-6-D-RES). Because the project is located within the Monterey Peninsula Country Club Subdivision No. 2 it is subject to the Del Monte Forest non-coastal area setbacks per Permit No. ZA00595. The project is an allowed land use for this site.

The parcel is partially undeveloped and is located on lot 23. The existing single family dwelling is established on lots 24 and partially on lot 23. For purposes of determining lot legality certificates of compliance where processed and approved (CC100014 & CC100015).

The project is located within a high archaeological sensitivity zone. Pursuant to Monterey County Zoning Ordinance Section 21.66.050, Standards for Archaeological Resource Areas, an archeological report is required for projects within a high archaeological sensitivity zone. An archeological report (LIB100060) was prepared on February 4, 2010 by Mary Doane, B.A. and Gary S. Breschini, Ph.D., RPA. The report concluded and did not reveal any of the indicators expected of a prehistoric archaeological site in this region. Accordingly, a standard condition of approval is recommended which requires that if, during the course of construction, cultural, archaeological, historical or paleontological resources are uncovered at the site (surface or subsurface resources) work shall be halted immediately within 50 meters (165 feet) of the find until a qualified professional archaeologist can evaluate it. The Monterey County RMA - Planning Department and a qualified archaeologist (i.e., an archaeologist registered with the Society of Professional Archaeologists) shall be immediately contacted by the responsible individual present on-site. When contacted, the project planner and the archaeologist shall immediately visit the site to determine the extent of the resources and to develop proper mitigation measures required for the discovery. (condition 2)

The project does not involve any tree removal however; Monterey Pine trees are protected in this area per Monterey County GIS system. No Oak trees six inches or more in diameter two feet above ground level shall be removed without appropriate permits per Monterey County Zoning Ordinance (Title 21).

The project was referred to the Del Monte Forest Land Use Advisory Committee for review per the guidelines adopted by the Monterey County Board of Supervisors Resolution No. 08-338.

Staff conducted a site visit on February 25, 2010, to verify that the project conforms to the area plans mentioned in this report.

The Suchy project as described is consistent with the plans and policies of the Monterey County General Plan, the Greater Monterey Peninsula Area Plan and the requirements and standards of the Monterey County Zoning Ordinance (Title 21); therefore staff recommends approval with the attached conditions.

This permit was approved in accordance with County ordinances and land use regulations subject to the following terms and conditions.
