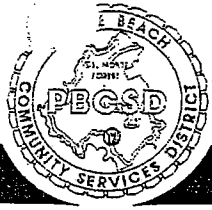

**Project Location:** The project will be located near the intersection of Colton and Bird Rock Roads, within the boundaries of the Pebble Beach Community Services District, Pebble Beach/Del Monte Forest, in and through the northern portion of Del Monte Forest, and in the western portion of the City of Pacific Grove, on the Monterey Peninsula, Monterey County, California.

**Project Description:** The Phase II - CAWD/PBCSD Wastewater Reclamation Project is composed of four major elements:

**A. Forest Lake Reservoir Modifications:**

Construction improvements will include a lining and underdrain system to stabilize the existing Forest Lake Reservoir embankments; a gravel access road on top of the reservoir embankment around the entire perimeter; a new emergency outlet/plant intake structure and appurtenances to enable the stored water to be removed from varying levels of the reservoir and thereby optimize the quality of reclaimed water being conveyed to the Forest Lake Treatment Facility; and a new overflow/drain pipeline and connection to an existing California-American Water Company ("Cal-Am") overflow pipeline. temporary construction access road will be constructed to provide heavy earthwork equipment access from Lopez Road, near its intersection with Forest Lake Road, in order to minimize traffic impacts on the adjacent residential areas.

B. *Forest Lake Treatment Facility:*

The existing Cal-Am treatment plant will be modified at Forest Lake Reservoir to remove algae from reclaimed water stored in the reservoir before it is placed back into the reclaimed water distribution system.

C. *Sawmill Gulch Emergency Outlet Structure:*

The outlet of the existing Cal-Am overflow/drain line will be extended by about 125 feet to Sawmill Gulch Creek and an energy dissipation structure will be constructed at the new outlet.

D. *Transmission Pipeline Extension:*

The existing reclaimed water distribution system will be extended through the Del Monte Forest from its current terminus at Spanish Bay and into the City of Pacific Grove to serve the Pacific Grove Municipal Golf Course and El Carmelo Cemetery. The entire length of the reclaimed water pipeline will be constructed in private or public street rights-of-way and in an easement on property currently owned by Southern Pacific Railroad.

This Notice of Determination is to advise that the lead agency, Pebble Beach Community Services District, has approved the above described project on February 23, 1996 (see attached Resolution 96-04) and has made the following determinations regarding said project:

1. The project, as approved, will not have a significant effect on the environment.
2. An Expanded Initial Study justifying a Negative Declaration was prepared for this project pursuant to the provisions of the California Environmental Quality Act ("CEQA").

A Negative Declaration was circulated and adopted for this project pursuant to provisions of CEQA.

3. Mitigation measures were made a condition of the approval of the project.

**A RESOLUTION OF THE PEBBLE BEACH COMMUNITY SERVICES DISTRICT  
APPROVING FINAL EXPANDED INITIAL STUDY AND ADOPTING FINDINGS  
IN SUPPORT OF A NEGATIVE DECLARATION,  
PHASE II - CAWD/PBCSD RECLAMATION PROJECT (FOREST LAKE RESERVOIR)**

**WHEREAS**, in order to determine if an Environmental Impact Report or a Negative Declaration must be prepared pursuant to the California Environmental Quality Act ("CEQA"), the District caused its consulting engineers, Parsons Engineering Science, to prepare a Draft Expanded Initial Study ("DEIS"), dated 11 December 1995, to provide a preliminary analysis of the physical, biological and socioeconomic impacts of the proposed Phase II, CAWD/PBCSD Reclamation Project which includes rehabilitation of Forest Lake Reservoir and extension of the existing reclamation project distribution system within the District and potentially to the City of Pacific Grove; and

**WHEREAS**, a Public Notice of a Proposed Negative Declaration and Draft Expanded Initial Study, dated 22 December 1995, regarding the proposed project was circulated to every Responsible Agency and Trustee Agency concerned with the project and every other public agency with jurisdiction by law over resources affected by the project, and said Public Notice was posted on the project property and on the public bulletin boards of the District and the United States Post Office in Pebble Beach; and

**WHEREAS**, all comments received on the proposed Negative Declaration and DEIS during the public review period which commenced on 22 December 1995 and ended on 2 February 1996 have been reviewed, evaluated and responded to in a Final Expanded Initial Study dated 22 February 1996; and

**WHEREAS**, this Board has reviewed and considered said Final Expanded Initial Study

in support of a Negative Declaration, including all proposed mitigation measures and comments submitted during the public review period.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of the Pebble Beach Community Services District, as follows that:

1. The Final Expanded Initial Study in support of a Negative Declaration for the proposed Phase II, CAWD/PBCSD Wastewater Reclamation Project dated 22 February 1996 is hereby approved.

2. This Board finds based on said Final Expanded Initial Study and mitigation measures included within the document that no significant environmental impacts have been identified that cannot be avoided or reduced to a level of insignificance by said mitigation measures which shall be incorporated into the design, construction, and operation of said proposed project, and therefore declares that the District should issue a Negative Declaration with the Final Expanded Initial Study of said proposed project.

3. The General Manager, in coordination with the District's consulting engineers, is directed to file, as required by CEQA guidelines, a Notice of Determination relating to said project.




## Findings of Exemption (attach required findings):
