

**APPROVING FINAL ADDENDUM TO EXPANDED INITIAL STUDY AND
ADOPTING FINDINGS IN SUPPORT OF NEGATIVE DECLARATION,
PHASE II - CAWD/PBCSD RECLAMATION PROJECT
(FOREST LAKE RESERVOIR)**

WHEREAS, in order to determine if an Environmental Impact Report or a Negative Declaration must be prepared pursuant to the California Environmental Quality Act ("CEQA"), the District caused its consulting engineers, Parsons Engineering Science, to prepare a Draft Addendum to Expanded Initial Study ("EIS"), dated May 2001, to provide a preliminary analysis of the physical, biological and socioeconomic impacts of the proposed modifications required by the California Department of Water Resources, Division of Safety of Dams for the Phase II, CAWD/PBCSD Reclamation Project – Forest Lake Reservoir; and

WHEREAS, a Public Notice of Proposed Negative Declaration and Addendum to EIS, dated 4 June 2001, regarding the proposed project was circulated to every Responsible Agency and Trustee Agency concerned with the project and every other public agency with jurisdiction by law over resources affected by the project, and to all property owners located within 300 feet of the project, and

WHEREAS, all comments received on the proposed Negative Declaration and Addendum to EIS during the public review period which commenced on 4 June 2001 and ended on 6 July 2001 have been reviewed, evaluated and responded to in a report prepared by the District Engineer; and

WHEREAS, this Board has reviewed and considered said findings in support of a Negative Declaration, including all proposed mitigation measures and comments submitted during the public review period.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Pebble Beach Community Services District, as follows that:

1. The Addendum to Expanded Initial Study in support of a Negative Declaration for the proposed Phase II, CAWD/PBCSD Wastewater Reclamation Project – Forest Lake Reservoir dated May 2001 is hereby approved.

2. This Board finds based on said Addendum to Expanded Initial Study and mitigation measures included within the document that no significant environmental impacts have been identified that cannot be avoided or reduced to a level of insignificance by said mitigation measures which shall be incorporated into the design, construction, and operation of said proposed project, and therefore declares that the District should issue a Negative Declaration with the Addendum to Expanded Initial Study of said proposed project.

3. The General Manager is directed to file, as required by CEQA guidelines, a Notice of Determination relating to said project.




