FINDINGS & DECISION

for an **Administrative Permit** in accordance with Title 21 (Zoning) Chapter 21.70 (Administrative Permits) of the Monterey County Code, to allow the demolition of an existing 2,768 sq. ft. one-story single family dwelling and the construction of a new two-story 5,587 sq. ft. single family dwelling within an "S" District and Design Approval. The other existing structures on the parcel include a second single family residence (1,482 sq. ft.), caretaker's unit (623 sq. ft.) and barn (1,400 sq. ft.) would remain. The property is located at 332 El Caminito Road, Carmel Valley, north of the intersection of Caminito Road and Ford Road, Carmel Valley Master Plan Area, and came on regularly for meeting before the Zoning Administrator on June 12, 2008.

Said Zoning Administrator, having considered the application and the evidence presented relating thereto,

FINDINGS & CONDITIONS

1. **FINDING: CONSISTENCY** – The project, as described in Condition No. 1 and as conditioned, conforms to the policies, requirements, and standards of the Monterey County General Plan, Greater Monterey Peninsula Area Plan, Greater Monterey Peninsula Area Plan Inventory and Analysis, Carmel Valley Master Plan, and the Monterey County Zoning Ordinance (Title 21), which designates this area as appropriate for residential development.

- EVIDENCE:**
- (a) The text, policies, and regulations in the above referenced documents have been evaluated during the course of review of applications. No conflicts were found to exist. No communications were received during the course of review of the project indicating any inconsistencies with the text, policies, and regulations in these documents.
 - (b) The property is located at 332 El Caminito Road Carmel Valley (Assessor's Parcel Number 187-591-056-000), Carmel Valley Master Plan. The parcel is zoned LDR/1-D-S ("Low Density Residential, 1 acre per unit, Design Review and Site Plan Review") which allows residential development. Therefore, the property is suitable for the proposed development.
 - (c) The project planner conducted a site inspection on January 18, 2007 to verify that the project on the subject parcel conforms to the plans listed above.
 - (d) Lot Legality. The project parcel was originally part of the Los Laureles Rancho (Carmel Valley). Recently, the Gardiner Minor Subdivision of 1990 (Assessor's Parcel Number 187-591-0013-000) created four parcels and the subject parcel is one of these four parcels.
 - (e) Caretaker's Unit was constructed prior to the current zoning adopted in 1986. The historical evaluation (listed below) of the site structures estimated that the Caretaker unit was constructed circa 1930's. Condition

number 11 addresses the current requirement to record a notice regarding the use of the caretaker unit.

- (f) The project was not referred to the Carmel Valley Land Use Advisory Committee (LUAC) for review. Based on the current review guidelines adopted by the Monterey County Board of Supervisors per Resolution No. 04-236, this application did not warrant referral to the LUAC because the project is exempt from CEQA per Sections 15303 and 15301; and the project does not involve a variance.
- (g) The application, project plans, and related support materials submitted by the project applicant to the Monterey County Resource Management Agency - Planning Department for the proposed development found in Project File PLN060547.

2. FINDING: SITE SUITABILITY – The site is physically suitable for the use proposed.

- EVIDENCE:**
- (a) The project has been reviewed for site suitability by the following departments and agencies: RMA - Planning Department, insert Fire Agency, Parks, Public Works, Environmental Health Division, and Water Resources Agency. There has been no indication from these departments/agencies that the site is not suitable for the proposed development. Conditions recommended have been incorporated.
 - (b) Technical reports by outside historical and geological consultants indicated that there are no physical or environmental constraints that would indicate that the site is not suitable for the use proposed. County staff concurs. The following reports have been prepared:
 - o “Historical evaluation of 332 El Caminito Road Carmel Valley” (LIB080022) prepared by Meta Bunse, JRP Historical Consulting, LLC, Davis, CA, April 20, 2006).
 - o “Geotechnical Investigation for proposed for 332 El Caminito Road Carmel Valley” (LIB080021) prepared by Haro Kasunich Inc, Watsonville, CA, April 28, 2006).
 - (c) The property is located at 332 El Caminito Road, Carmel Valley” (Assessor’s Parcel Number 187-591-056-000), Carmel Valley Master Plan. The parcel is zoned LDR/1-D-S, or (“Low Density Residential, one acre per unit, Design Approval and Site Review”). The subject property complies with all the rules and regulations pertaining to zoning uses and any other applicable provisions of Title 21, and is therefore suitable for the proposed development.
 - (d) Staff conducted a site visit on January 18, 2007 to verify that the site is suitable for this use.
 - (e) Materials in Project File PLN060547.

3. FINDING: CEQA (Exempt): - The project is categorically exempt from environmental review and no unusual circumstances were identified to exist for the proposed project.

- EVIDENCE:**
- (a) California Environmental Quality Act (CEQA) Guidelines Section 15303 and 15301; categorically exempts demolition of individual small structures (i.e. single family residence) and construction of a single family residence.
 - (b) No adverse environmental effects were identified during staff review of the development application during a site visit on January 18, 2007.

- (c) The application, project plans, and related support materials submitted by the applicant to the Monterey County RMA - Planning Department for the proposed development, found in Project File PLN060547.
- (d) See findings above and supporting evidence.

4. **FINDING:** **NO VIOLATIONS** - The subject property is in compliance with all rules and regulations pertaining to zoning uses, subdivision, and any other applicable provisions of the County's zoning ordinance. No violations exist on the property. Zoning violation abatement costs, if any, have been paid.

EVIDENCE: Staff reviewed Monterey County RMA - Planning Department and Building Services Department records and is not aware of any violations existing on subject property.

5. **FINDING:** **HEALTH AND SAFETY** - The establishment, maintenance, or operation of the project applied for will not under the circumstances of this particular case be detrimental to the health, safety, peace, morals, comfort, and general welfare of persons residing or working in the neighborhood of such proposed use, or be detrimental or injurious to property and improvements in the neighborhood or to the general welfare of the County.

EVIDENCE: Preceding findings and supporting evidence.

6. **FINDING:** Design Approval- this project is in compliance with the Design Approval District purpose (Ordinance 21 Section 21.44.010) as to the neighborhood character, public viewshed and visual integrity without imposing undue restrictions of private ownership.

EVIDENCE:

- a) The owner submitted a Design Approval Request form on January 4, 2008 with the permit submittal packet.
- b) The visual impacts of the proposed structure were reviewed with regard to the location, size, configuration, materials, and colors. There were no substantially adverse visual impacts observed on the staff site visit on January 18, 2007.
- c) The colors and materials proposed include natural colored weathering steel (fireproof) roofing, natural redwood siding, bronze windows, desert beige limestone chimney and walls, and birdbath tan stucco walls. The neutral colors and types of materials fit well into the wooded knoll site. The colors also blend well with the existing neighborhood choice of home colors.
- d) The existing single family residence is located in between large mature oak trees. The existing site will be utilized without the removal of any trees. The proposed new residence has been carefully designed and located to fit within the exiting trees. The same visual protection provided today will apply in the future even with the enlarged footprint.
- e) The proposed two story residence will be only 6.5 feet taller than the existing 18 foot tall residence. The proposed two-story residence is 23.5 feet tall from average natural grade. It is well within the 30 foot height limit of the LDR zone.
- f) The view from the closest (Mahady) residence will have a negligible change. The nearest residence is about 100 feet below and 800 feet removed from the building site. The project is not visible from a common public viewing area. Additionally the tall oaks effectively screen the

proposed structure from view, when viewed from the developed adjacent ridges.

- g) The above findings and evidence.
- h) The staff conducted site visit on January 18, 2007
- i) The materials in the project file pln060547.

7. **FINDING: APPEALABILITY** - The decision on this project is appealable to the Planning Commission.

EVIDENCE: Section 21.80.040 of the Monterey County Zoning Ordinance (Title 21).

DECISION

THEREFORE, it is the decision of said Zoning Administrator, that said application for an Administrative Permit be granted as shown on the attached sketch, subject to the following conditions:
