#### Parks



## Cooperative Extension

Cooperative Extension's Nutrition Program Manager has been working throughout the county with schools to promote healthy eating and lifestyles. One of the tools used in this effort is the UC Cooperative Extension-developed curriculum entitled "EatFit". The schools and teachers are working hard to incorporate evidence-based behavioral change metrics into their evaluation plans.

Here are some comments from a handful of parent letters offered in feedback for the "EatFit" curriculum. In addition, the family's health is improved as youth bring the lessons learned home to their parents.

## **Elections**

June 8, 2010 Consolidated Statewide Primary: As of Monday, the June Primary is 29-days away. Current activities surround the required Logic and Accuracy testing, cleaning and organizing materials for the polling places, candidate write-in nomination period, preparation for early voting at the Department, and processing voter registration forms for eligible voters.

Election Mail: Last week's report indicated the Department would be mailing out all permanent and mail ballot precinct voters their vote by mail voting materials beginning Monday, May 10. Due to the significantly late translations from the State, almost every county was delayed in delivering the official format to their printer. Mail will be delivered to the Salinas post office for delivery on Thursday, May 13.



Vote by mail ballots will be available at the Department's office in Salinas beginning Monday, May 10, as required by law for those who wish to obtain a ballot in person.

June 22 and August 17, 2010 Special Vacancy Elections – Senate District 15: On Thursday, May 6, a lawsuit was filed in the United States District Court, Northern California District in San Jose on behalf of three Monterey County minority voters naming the County of Monterey and the State of California as Defendants, seeking declaratory and injunctive relief and asking the Court to prevent the continued implementation of the Special Vacancy Elections unless and until the required approval for the election, and any voting process changes, under Section 5 of the Voting Rights Act has been obtained. Monterey County is one of five counties involved in the Special Vacancy Election in Senate District 15 and is the only county required to submit voting changes to the Department of Justice for preclearance no less than 60-days before the change is implemented. No court date has been set.

The deadline for candidates seeking to have their name placed on the June 22 ballot is today, May 10, 2010 at 5:00 p.m.

#1414 Related to Transportation and Local Government Funds; #1454 Related to Global Warming. Both received 5/4/2010; Waiting for Random Sample
#1408 Related to 2/3 Vote on State Budget. - Received 5/7/2010 Waiting for Random Sample
