This Week's Topics: Monterey County's Fleet Operations is honored, Out and About in Monterey County - The Red Bull MotoGP and Moss Landing's Antique Faire Celebrates a Milestone.

Monterey County's Fleet Operations has received an honorable mention award from



Government Fleet's 100 Best Fleets program. Monterey County has been honored by this organization for its fleet management for the last three years.

Government Fleet Magazine, which serves government sector fleet management, provides a yearly Top 100 listing of government fleets around that nation.

Government Fleet evaluates operations based on a variety of criteria including efficiency, savings and increased availability.

Parks

The Red Bull U.S. Grand Prix was held at Laguna Seca Recreation Area on July 23rd through the 25th.

Attendance is still being finalized, but is estimated at 116,000 over the 3-day event, which is an increase over 2009. The opening of this year's race included the Stanford Marching Band, an F-16 flyover, Red Bull skydivers and the Red Bull helicopter stunt team.



“I am so happy to win here at Laguna Seca, it’s something I’ve always dreamed of,” said Jorge Lorenzo, winner of the 2010 Red Bull U.S. Grand Prix on Sunday, July 25th. The Laguna Seca win was Lorenzo’s sixth and increases his lead for the 2010 championship. Defending champion, Dani Pedrosa, crashed in the twelfth lap leaving room for Casey Stoner, the 2007 winner, to finish in second place. Valentino Rossi, seven-time series champion, finished third. The U.S. Grand Prix was the main event for the race weekend which included four other races.

The Mazda Raceway Laguna Seca event was the ninth race of an eighteen race international series which ends in Spain on November 7th.
