### **Environmental Ag Workshop**

On March 30, 2011 the Environmental Health Bureau, in cooperation with the Monterey County Farm Bureau and the Growers Shippers Association, will hold its annual Environmental Compliance Workshop for locals in the agriculture industry, at the Salinas Valley Fairgrounds in King City.



This workshop has been held annually since 2001 and is designed to assist growers and other agriculture-related businesses to stay in compliance with environmental laws and regulations. Agricultural operations often use hazardous materials, generate hazardous wastes, and store chemicals in aboveground and underground tanks, all of which may pose threats to health, safety and the environment if handled improperly. Also on the agenda at this year's workshop, agriculture-related crime and the Monterey Bay Marine Sanctuary's Agricultural and Rural Lands Plan.

The workshop is free and is funded by settlements from previous environmental enforcement cases as well as sponsorships from local agriculture businesses.

## **County Cleanup Day**

There is still plenty of time to sign up to take part in the 6th Annual Monterey County

Cleanup Day on April 16, from 8:00 a.m.-Noon. Do something good for the community and celebrate Earth Day this year by taking part in cleanup efforts on this special day.

The Recycling and Resource Recovery Service of the Health
Department's Environmental Health Bureau, along with the Monterey
County Illegal Dumping and Litter Abatement Task Force, coordinates with community

members to help combat illegal dumping and litter abatement.

To date, 31 cleanup sites have been planned in locations from Del Monte Beach in Monterey to Natividad Creek Park in Salinas. E-waste drop offs also will be available.
