<u>1.</u> JOHN R DEA – PLN050577

Jody Lyons, Project Planner, presented the Use Permit to allow the removal of 23 oak trees to allow the placement of a 1,688 square foot manufactured home with an attached 768 square foot garage, pumped septic system and 700 cubic yards of grading (400 cubic yards cut and 300 cubic yards fill). The property is located at 7586 Langley Canyon Road, Salinas in the North County Non-Coastal Zone.

Staff recommended approval of the Use Permit.

Wendy Strimling, County Counsel, notes that the report should state "Approve the project based on the recommended Findings and Evidence and subject to the Recommended Conditions of Approval.

Clarification was needed from Water Resources Agency concerning the replacement of a condition of approval regarding drainage.

2. MONTEREY PENINSULA REGIONAL PARK – PLN050638

Mike Novo, Acting Secretary, with the request from the applicant that the Combined Development Permit consisting of a Coastal Development Permit to allow a change in sue from Watershed and Scenic Conservation to Public Quasi-Public to provide interim public access to designated parkland areas along an existing roadway network consistent with the Palo Corona Interim Access Management Plan; a Coastal Administrative Permit to allow the installation of a 49 square foot portable chemical toilet, and a Design Approval to allow the installation of interpretive and directional signage.
