The Special Meeting of the Planning Commission met at 9:00 a.m. in the Board of Supervisors Chambers of the Courthouse, 168 West Alisal Street, Salinas, California. Vice Chairman Aurelio Salazar chaired the hearing.

**1. 2006 GENERAL PLAN**

APPOINT SUBCOMMITTEE AND PROVIDE DIRECTIONS FOR SUBCOMMITTEE DELIBERATIONS.

Carl Holm, Interim Manager – Coastal Team, discussed the appointment of planning commissioners to serve as a Subcommittee for the General Plan. The Board of Supervisors requested that the Subcommittee consist of one commissioner from each Supervisorial District. This subcommittee would establish a timeline to work within the parameters that have been established by the Board.
