COMBINED DEVELOPMENT PERMIT CONSISTING OF A USE PERMIT FOR THE CHANGE IN A LEGAL NON-CONFORMING RESIDENTIAL USE IN ACCORDANCE WITH SECTION 21.68.020.C OF THE MONTEREY COUNTY ZONING ORDIANCE (TITLE 21) AND A LOT LINE ADJUSTMENT BETWEEN TWO LEGAL LOTS OF RECORD OF APPROXIMATLEY 4.04 ACRES (PARCEL 1) AND 2.50 ACRES (DARCEL 1) AND 1.11 ACRES (PARCEL 2), RESULTING IN 2.64 ACRES (PARCEL A) AND 2.50 ACRES (PARCEL B), 1.11 ACRES (PARCEL 2), KESULING IN 2.04 LOCATED AT 18182 VIERRA CANYON ROAD, CARCEL B), RESPECTIVELY. # 2. LUGO RUBEN (PLN050669)

MINOR SUBDIVISION TENTATIVE MAP TO ALLOW THE DIVISION OF AN 89 ACRE PARCEL INTO 2 PARCELS OF 49 ACRES (PARCEL A) AND 40 ACRES (PARCEL B) RESPECTIVELY AND A AN EXISTING 30' ROAD EASEMENT LOCATED ON PROPOSED PARCEL "B" AND WILL BE EXTENDED FOR ACCESS TO PARCEL "A". A wording change was requested for Condition #4.

Danielle Brown, agent, agreed with the conditions and changes.

Ruben Lugo, applicant, questioned Environmental Health's request to destroy the well.

After discussion, Environmental Health said they will replace condition #24 to destroy the well with a non-standard condition that states that the well will only be used for irrigation. (Applicant agreed to the change.)
