CONTINUED FROM 11/8/07. COASTAL DEVELOPMENT PERMIT TO ALLOW A LOT LINE ADJUSTMENT WHERE 1,355 SQUARE FEET IS ADDED TO PARCEL A (ASSESSOR'S PARCEL NUMBER 009-032-014-000, 24230 SAN PEDRO LANE) AND 1,355 IS SUBTRACTED FROM PARCEL B (ASSESSOR'S PARCEL NUMBER 009-032-002-000, 24300 SAN PEDRO LANE) TO ACCOMMODATE AN EXISTING GARAGE ON PARCEL A THAT IS BUILT OVER THE PROPERTY LINE. 2. SPANISH CONGREGATION (ZA06672)

COASTAL DEVELOPMENT PERMIT FOR A MINOR SUBDIVISION OF 20 ACRES CREATING FOUR PARCELS OF 3 ACRES, 3 ACRES, 3 ACRES AND 11 ACRES. AN EXISTING CHURCH WILL REMAIN ON THE 11 ACRE PARCEL. THE PROPERTY IS LOCATED AT 125 SILL ROAD (KINGHALL ROAD), LAS LOMAS (ASSESSOR'S PARCEL NUMBER 412-071-003-000), NORTH COUNTY AREA, COASTAL ZONE.

Liz Gonzales, Project Planner, presented the project. Staff provided an errata memo for the changes and modifications to the staff report. The changes were discussed by staff.

McPharlin expressed concern regarding water availability. Staff replied that a can and will serve letter from California Water Service Company has been received and is in the file.

Tom Moss made changes to Condition No. 14, Road Improvement Plan – delete first sentence of condition and timing should be changed to "prior to issuance of grading permit and recordation."

Alana Knaster, RMA Chief Assistant Director, clarified the definition of a pipeline project and answered questions.

John Bridges, representative, clarified a water question.

Public Comment: Marjorie Kay voiced opposition to the project.

McPharlin discussed the concern over water in North County.

Vandevere relayed that he could not support the project due to water concerns.

Onciano inquired about direction from the Board regarding a pipeline cutoff date.

Carl Holm, RMA Assistant Director of Planning, gave clarification regarding policies governing this subdivision and read a portion of the Initial Study regarding water.

Moss relayed how the fee was used. He will support the project.

It was moved by Tom Moss to adopt the Mitigated Negative Declaration and approve the project. (Motion died for lack of a second).

It was moved by Vandevere and seconded by McPharlin to direct staff to prepare a resolution to deny the project. (Motion failed).
