COMBINED DEVELOPMENT PERMIT CONSISTING OF A COASTAL DEVELOPMENT PERMIT TO ALLOW THE REMOVAL OF FOUR OAK TREES (15 INCHES, TWO 14 INCHES AND 8 INCHES IN DIAMETER). AND A COASTAL ADMINISTRATIVE PERMIT TO ALLOW THE DEMOLITION OF AN EXISTING CARPORT AND GARAGE AND TO CONSTRUCT A 647 SQUARE FOOT GARAGE LOCATED NEAR AN EXISTING DRIVEWAY. THE EXISTING ASPHALT DRIVEWAY TO BE REPLACED WITH DECOMPOSED GRANITE PAVING. THE PROPERTY IS LOCATED AT 1470 PADRE LANE, PEBBLE BEACH (ASSESSOR'S PARCEL NUMBER 008-453-021-000), DEL MONTE FOREST AREA.

2. CALIFORNIA-AMERICAN WATER CO (PLN080005)

USE PERMIT AND DESIGN APPROVAL TO ALLOW THE INSTALLATION OF A PRE-FABRICATED SKID MOUNTED ARSENIC TREATMENT SYSTEM AT AN EXISTING WELLHEAD SITE. THE FACILITIES WILL CONSIST OF A SMALL CONCRETE BASE SLAB TO INCLUDE FOUR (4) BACKWASH TANKS APPROXIMATELY 10 FEET IN DIAMETER AND 10 FEET IN HEIGHT; ONE (1) SLUDGE DISPOSAL TANK APPROXIMATELY 8 FEET IN DIAMETER AND 13 FEET IN HEIGHT; MISCELLANEOUS PIPING, PUMPS AND CONTROLS. THE 2.58 ACRE PROPERTY IS LOCATED AT 776 MONTEREY-SALINAS HIGHWAY ON THE SOUTH SIDE OF HIGHWAY 68 BETWEEN LAURELES GRADE ROAD AND CORRAL DE TIERRA ROAD, SALINAS (ASSESSOR'S PARCEL NUMBER 161-451-002-000), TORO AREA.
