RECOMMENDATION:

Staff recommends that the Planning Commission adopt the Resolution to acknowledge the abandonment of Use Permit (Resolution No. 05029) for a Bed and Breakfast Facility and direct staff to pursue an amendment of the January 9, 2007 Traffic Impact Fee Agreement.

PROJECT OVERVIEW:

On June 29, 2005, the Planning Commission approved a Use Permit for Tim Arthur Williams et al (Resolution No. 05029/PLN040720) for a Bed and Breakfast Facility. On December 13, 2006, the Planning Commission directed Planning staff to prepare a report on of condition compliance. Planning staff presented the status report on January 31, 2007. At the January 31, 2007 meeting, the Planning Commission directed staff to set a public hearing before the Planning Commission on March 28, 2007 to modify or revoke the Use Permit, and, at applicant's request, the Planning Commission subsequently changed the hearing date to April 25, 2007. A duly noticed hearing was held on April 25, 2007 with staff recommendation to modify the approved Use Permit. At the hearing, the applicants submitted a letter stating that they were abandoning their Use Permit for a Bed and Breakfast Facility and testified that the abandonment was effective immediately. The Planning Commission directed staff to prepare a resolution to acknowledge abandonment of the Bed and Breakfast Facility Use Permit (Resolution No. 05029) to recommend an appropriate reduction in the traffic impact fee, and the Planning Commission continued the hearing to May 30, 2007 to consider the resolution.

Note: The decision on this project is appealable to the Monterey County Board of Supervisors.

In January 7, 2007, to fulfill condition of approval number 11 of the Use Permit, the Board of approvisors approved a Traffic Impact Fee Agreement with the owners requiring that the owners that the County a fee of \$77,432.00 based on an assessment of the impacts of the permitted use. anning staff presented a status report to the Planning Commission on January 31, 2007. The anning Commission directed staff to set a public hearing to modify or revoke the Use Permit. In April 25, 2007, the Planning Commission held a duly noticed public hearing to modify or voke the permit. In April 25, 2007, the owners provided the County with a letter withdrawing the permit (see tached), and the owner testified at the Planning Commission hearing that the owners were andoning the permit effective immediately. The Planning Commission continued the hearing to any 30, 2007 with direction to staff to prepare and present a resolution acknowledging the owners' andonment of the Use Permit and recommending an appropriate reduction in the traffic impact
