The Draft 2007 General Plan Update was released in December, 2007. A Draft Environmental Impact Report was prepared and released for public comment in September 2008. The public comment period closed on February 2, 2009.

Per direction from the Planning Commission on January 28, 2009, staff will provide an oral report on text and modifications to the GPU pursuant to Board direction in November 2007 and mitigation measures proposed in the DEIR (**Exhibits A and B**) The focus of the oral report will be on the Open Space and Conservation Element, the Land Use Element and the Public Services Element (**Exhibit C**). The Draft Land Use Element incorporates errata provided to the public on 9-08.

The Commissioner may take testimony on any aspect of the 2007 Draft General Plan Update.
