Attached are some additions to the CIP that the Planning Commission is considering today to determine consistency with the General Plan. These additions are remodeling, software, and equipment changes except the last item, a rebuilt entry gate at Lake San Antonio.

In addition, we have additional information related to the Artichoke Avenue item (Spreadsheet First Page, second Redevelopment Agency item). The Project Description should include that the item requires a Local Coastal Program amendment to construct the project. With the amendment, the project is consistent with the General Plan. If an amendment is not approved by the California Coastal Commission, the project would not be constructed as planned. The General Plan consistency finding does not change for this item as a result of this information.
