Project Planner: Bob Schubert. **Environmental Status**: Addendum to Final EIR for the Commuter Rail Extension to the Monterey Project. **Project Description**: 1) Combined Development Permit consisting of a Use Permit and General Development Plan to allow the construction of the Castroville train station and parking lot adjacent to existing railroad tracks; and 2) Combined Development Permit consisting of a Use Permit, General Development Plan and Design Approval to allow the construction of the Pajaro train station and parking lot adjacent to existing railroad tracks.

Project Planner: Elizabeth Gonzales. Environmental Status: Draft Environmental Impact Report prepared. Project Description: CONTINUED FROM JUNE 29, 2011. Adopt a Resolution to Recommend Denial to the Board of Supervisors of the proposed LCP Amendments to the Carmel Area Land Use Plan and Coastal Implementation Plan, Chapter 20.146.120 (Land Use and Development Standards). The address is 24945 Valley Way, Carmel (Assessor's Parcel Numbers 009-061-002-000, 009-061-003-000, 009-061-005-000), Coastal Zone.
